TERMS OF WEBSITE USE

This page (together with the documents referred to on it) tells you the terms of use on which you may make use of our website www.mycelebpt.com (our site), whether as a guest or a registered user. Please read these terms of use carefully before you start to use the site. By using our site, you indicate that you accept these terms of use and that you agree to abide by them. If you do not agree to these terms of use, please refrain from using our site.

1. These Terms and Conditions will apply to the purchase of the services and goods by you (the **Customer** or **you**). We are DSD Media Ltd whose trading name is My Celeb PT a company registered in England and Wales under number 09178264 whose registered office is at 3 Brunswick Street, Merseyside, L2 0PQ with email address hello@mycelebpt.com; (the **Supplier** or **us** or **we**).
2. These are the terms on which we sell all Services to you. Before placing an order on the Website, you will be asked to agree to these Terms and Conditions by clicking on the button marked 'I Accept'. If you do not click on the button, you will not be able to complete your Order. You can only purchase the Services and Goods from the Website if you are eligible to enter into a contract and are at least 18 years old or have parental permission.

All payments are handled via Stripe. All programs are recurring subscriptions and can be cancelled at any time through the app or email enquiries@mycelebpt.com to do this for you. When payment is cancelled the workouts are automatically removed from the app. Programs have scheduled payment variations i.e. the Home Program payment is set up for every 6 weeks, the glute program is set up for every 4 weeks etc.

Please note that payments are called for 7 days prior to your payment being taken from your bank account, so if you wish to cancel your payment, we require 2 weeks' notice prior to your payment date. If we do not receive this notice payments may still be taken.

JURISDICTION AND APPLICABLE LAW

The English courts will have exclusive jurisdiction over any claim arising from, or related to, a visit to our site although we retain the right to bring proceedings against you for breach of these conditions in your country of residence or any other relevant country.
